# **Privacy policy**

We recognize that the protection of personal information is an important social responsibility as well as an essential requirement for promoting corporate activities with the trust of society. The Company gives due consideration to the appropriate management and use of customers' personal information and implements the following measures

#### 1. Management of personal information

The Company will appoint a person responsible for managing your personal information and manage it appropriately in accordance with the Company's regulations on personal information protection.

## 2. Purpose of Use and Scope of Collection

## 3. How we use your personal information

In principle, the Company will use personal information only within the scope of the purposes notified to the customer or announced at the time of collection, and will not use it for any other purpose without the prior consent of the customer. However, we will not use the information for any other purposes without the consent of the customer in advance, except when required by law.

#### 4. Prohibition of provision and disclosure of information to a third party

We will not provide or disclose your personal information to a third party unless we have your consent or there is a legitimate reason to do so, such as when required by law.

### 5. Supervision of subcontractors

When we disclose your personal information to our subcontractors in order to achieve the purpose of use agreed upon by you, we will contractually obligate the subcontractors to strictly manage your personal information at the same level as we do, and we will supervise them in an appropriate manner to ensure that they do so.

#### 6. Ensuring and improving information security

We will continue to ensure and improve information security to prevent leakage, loss, and falsification of customers' personal information.

### 7. Education and Awareness

The Company will educate and enlighten all of its directors and employees to understand the importance of protecting personal information and to handle customers' personal information appropriately.

#### 8. Response to disclosure, correction and suspension of use of personal information

If you wish to request disclosure or correction of your own personal data and personal information, we will respond without delay and to the extent required by law, upon verifying your identity.

#### 9. Continuous Review and Improvement

The Company will comply with laws and regulations relating to personal information protection, and will continuously review and improve its measures to protect personal information in response to changes in the social environment.
